

Wetsuit Hire Contract

\$50 for 1-3 day wetsuit hire and \$119 for 1month

Delivery charge: \$10 (if Applicable)

Payment: Cash or Credit Card

Deposit: \$200 Cash or Credit Card Number

Delivery: 1-4 Days. We will endeavor to get items delivered next day. Signature is required on delivery, so please make sure we have an address where someone will be able to provide this

Return: We require the return of the wetsuit on the Monday after use, By Guaranteed Next Day Delivery. Failure to return the suit to us on time will incur another hire charge and loss of deposit plus any other expenses or losses involved.

Refunds: No refunds will be given for non use of Wetsuits

Sizes: We are happy to help you out with size. Provide Height, Weight and Chest Size and we will try and match you with correct size, but cannot guarantee a perfect fit.

Purchase: If you are pleased with your **wetsuit** you can **purchase** it at the end of the **hire** period. Please contact us in order to do so. The Hire fee will be deducted from the retail price of the suit

Please read the following Conditions Carefully

Please **DO Not** use Vaseline or any other grease as this grease can cause damage, is extremely difficult to remove and MOST unpleasant for other users.

If you damage the wetsuit you may be liable for the cost (**minimum of \$100**) of the repair, (fair wear and tear accepted). All suits are inspected prior to and after each hire period and any damage is noted. Should you damage a wetsuit please notify us. If the wetsuit is lost or stolen or you fail to return it to us you will be liable for full replacement costs of a new suit at current prices. Please make sure you are covered by adequate insurance.

Late or Non Return of Wetsuit: If your hire wetsuit is not in our possession by the end of the agreed hire term we will charge you for the outstanding value of the wetsuit.
